Ontario Federation of Agriculture

Jackie Pemberton and Bernard VanderZweep of Dundas Federation of Agriculture addressed Council about the Premier's Agri-Food Growth Challenge and the farming community concerns. They urged Council to pass a resolution to have the government of Ontario re-examine this program and to consult with the farming community.

Resolution No. 14-18-380 WHEREAS the increase in property tax resulting from a reclassification from farm to Commercial/Industrial prohibits many farm businesses from engaging in on-farm retail, processing and other value-added activities; and

WHEREAS these activities will lead to increased investment, create jobs and boost the local economy; and

WHEREAS the Premier issued an Agri-Food Growth Challenge to double the annual growth rate of the agri-food sector and create 120,000 new jobs by 2020;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of South Dundas asks the government of Ontario to examine the Ontario Federation of Agriculture's proposal for how to classify and tax the land and buildings associated with on-farm value-added activities, and enact the proposal or a reasonable modification of it, with a view to encourage farm businesses to further invest in these activities to stimulate the rural economy and help meet the Ontario Premier's Agri-Food Growth Challenge;

BE IT FURTHER RESOLVED THAT this resolution be circulated to all municipal and regional councils in Ontario requesting that they endorse and support this resolution and communicate their support to the Premier, and her Ministers of Finance, Economic Development and Tourism, and Agriculture, Food and Rural Affairs. CARRIED
