#### 68 St. Lawrence Street

The public meeting was cancelled as the owner had requested to cancel the zoning changes and has decided to retain the current residential zoning as Residential Fourth Density Special.

#### 4295 Boucks Hill Road

The Director of Planning & Enforcement explained that the land at West Part Lot 24 Concession 5, of the former geographic Village of Williamsburg, known municipally as 4295 Boucks Hill Road was subjected to a consent application which resulted in the severance of a residential parcel from the southeast corner of the larger farm parcel. This Zoning By-law amendment is needed to fulfill a condition of approval of Consent Application B-79-17 wherein the severed lot does not meet the minimum lot frontage required in the Residential Hamlet Zone. The severed parcel currently zoned Residential Hamlet (RH) will be rezoned to Residential Hamlet Special Exception 22 (RH-22) to reduce the minimum required lot frontage from 40 meters to 17 metres. The zoning on the retained parcel is not being changed; it will remain zoned as Residential Hamlet (RH) and Agriculture Special Exception 22 (A-22).

This Zoning By-law Amendment is not related to any Minor Variance, Official Plan Amendment or Plan of Subdivision. The lands are designated under the Stormont, Dundas and Glengarry Official Plan as Agriculture Resource Area.
