RESOLVED/ENACTED:

1. THAT all cheques of the Corporation drawn on its "General, Reserve, Cemetery, Campsite, Marina, OHRP" account(s) be signed on its behalf by Evonne Delegarde - Mayor, Jim Locke -

Deputy Mayor, Shannon Geraghty - Treasurer, Stephen McDonald - CAO - or any two of them (each an "Authorized Signatory") is/are authorized for and on behalf of the Corporation:

- (a) to negotiate with, deposit with or transfer to Bank of Montreal (the "Bank") (but for credit to the Corporation's account only) all or any bills of exchange, promissory notes, cheques and orders for the payment of money and other negotiable instruments, and for the said purpose to endorse the same on behalf of the Corporation (by rubber stamp or otherwise);
- (b) to arrange, settle, balance and certify all books and accounts between the Corporation and the Bank; and to receive all paid cheques and vouchers, unpaid and unaccepted bills of exchange and other negotiable instruments;
- (c) to obtain delivery from the Bank of all or any stocks, bonds and other securities held by the Bank in safekeeping or otherwise for the account of the Corporation and to give valid and binding receipts therefore.

REPEAL OF PREVIOUS RESOLUTIONS

- 2. THAT all resolutions, as applicable, (if any) with respect to the account(s) specified in section A1 and as to banking and signing officer(s), member(s) or any one or more Authorized Signatory (ies) passed by the Council, Assembly or Board of Trustees or other governing body, as applicable, of the Corporation and relating to the account(s) specified in section A1 held with the Bank previous to this resolution are repealed.
