# 1. 13490 Grantley Road

The Director of Planning & Enforcement explained that the land at East Part of Lot 10, Concession 8 of the former Township of Williamsburg,

known municipally as 13490 Grantley Road is currently zoned Agricultural Special Exception 28 (A-28) and was subject to a consent application which resulted in the severance and addition of 6.04 acres of land containing an apple orchard to the existing dwelling lot. A vacant farm parcel comprises the bulk of the property.

The zoning is being changed by rezoning the lot benefitting from the lot line adjustment parcel zoned as Agricultural Special 28 (A-28) to Agricultural Special Exception 45 (A-45).

The Director of Planning & Enforcement received no verbal or written concerns. The applicant was not present and Council did not have any concerns or objections.

# 2. 11750 County Road 2

The Director of Planning & Enforcement explained that the land at Part Lots 2 and 3, Concession 1 of the former Township of Matilda, known municipally as 11750 County Road 2 is currently zoned Residential Mobile Home Special Exception 1 (RMH-1) and the purpose is to rezone the lot to permit a tent and trailer park subject to the Municipality's satisfaction that the proposed development can be adequately serviced and that all approvals have been obtained.

The zoning is being changed by rezoning a portion of the property zoned Residential Mobile Home Special Exception 1 (RMH-1) to Tourist Commercial Special Exception 1 holding (CT-1-h).

The Director of Planning & Enforcement received correspondence from two concerned citizens that were read in open Council. However, other members of the public present requested Council to receive further input from residents that had travelled south for the winter. The Planning Act requirements for notice have been met and proper notice has been given. However, Council decided to defer their decision until the next meeting to allow extra time to gather further information on any other concerns.

The Director of Planning & Enforcement explained that the CT-1-h addresses any issues with the proposed development.

# 3. School Board Update

WHEREAS the Upper Canada District School Board (UCDSB) has commenced a Pupil Accommodation Review study that may result in the closure of dozens of schools across the Board, many in SDG; AND

WHEREAS the aggressive timelines imposed by the UCDSB simply do not allow for sufficient time for adequate and reasonable public consultation and review by those impacted by the closures; AND

WHEREAS it is understood that no discussion is contemplated or taken place between the UCDSB and the 3 other local school boards regarding sharing underutilized space; AND

WHEREAS schools are an essential element of the fabric of our rural communities;

NOW THEREFORE we, the 32 elected representatives (upper and lower tier) of the 65,000 residents of Stormont, Dundas and Glengarry, collectively demand that the PAR being undertaken by the UCDSB be immediately suspended for a period of 1 year, to allow adequate time to complete the work necessary to chart the course ahead that is in the best interests of all UCDSB students, AND FURTHERMORE

THAT the policy issued by the Ontario Ministry of Education on March 26, 2015, deleting the requirement that local school boards take into consideration the social, economic or geographic implications of school closures, be immediately reviewed, given the devastating impact this policy has on rural schools.
