19 Miller St

The Director of Planning & Enforcement explained that the purpose of this Zoning By-law Amendment is to rezone the land at Part of 3 on Plan 97, Part 2, of the former geographic Village of Iroquois, known municipally as 19 Miller Street from General Commercial (GC) to Residential First Density (R1). This amendment is needed to remove the commercial uses from the permitted uses and permit the uses in the RH zone.

This Zoning By-Law Amendment is not related to any Minor Variance, Official Plan Amendment or Plan of Subdivision.

The Director of Planning & Enforcement received no verbal or written concerns. The applicant was not present, and Council did not have any concerns or objections.

3615 Coons Rd

The Director of Planning & Enforcement explained that the land at Part Lot 9 and 10, Concession 7, of the former Township of Matilda, known municipally as 3615 Coons Road was subject to a Consent Application which resulted in the severance of a surplus dwelling lot from a vacant farm parcel comprising the bulk of the property.

This Zoning By-law Amendment is needed to fulfill a condition of approval of the aforementioned consent application wherein no new permanent residential uses are to be allowed on the vacant farm parcel.

The zoning is being changed by rezoning the retained parcel from Agricultural Special Exception 28 (A-28) to Agricultural Special Exception 57 (A-57) and the severed parcel from Agricultural Special Exception 28 (A-28) to Agricultural Special Exception 58 (A-58).

This Zoning By-law Amendment is not related to any Minor Variance, Official Plan Amendment or Plan of Subdivision.

The Director of Planning & Enforcement received no verbal or written concerns. The applicant was not present, and Council did not have any concerns or objections.

4296 County Rd 31

The Director of Planning & Enforcement explained that the purpose of this Zoning By-law Amendment is to rezone the land at Part Lot 31, Concession 5, of the former geographic Township of Williamsburg, known municipally as 4296 County Road 31 from Industrial (I) to Residential Fourth Density Special Exception 17 (R4-17) where the minimum required rear yard depth is reduced from 7.5 meters to 2 meters to accommodate the existing building, the minimum dwelling unit area of a one bedroom unit is reduced from 55 square meters to 49 square meters, and the required setback for an accessory building from an interior side lot line is reduced from 1.5 meters to 1.2 meters. This amendment is needed to remove the Industrial uses from the permitted uses and permit the uses in the RH zone.

This Zoning By-Law Amendment is not related to any Minor Variance, Official Plan Amendment or Plan of Subdivision.

The Director of Planning & Enforcement received no verbal or written concerns. The applicant was not present, and Council did not have any concerns or objections.
