

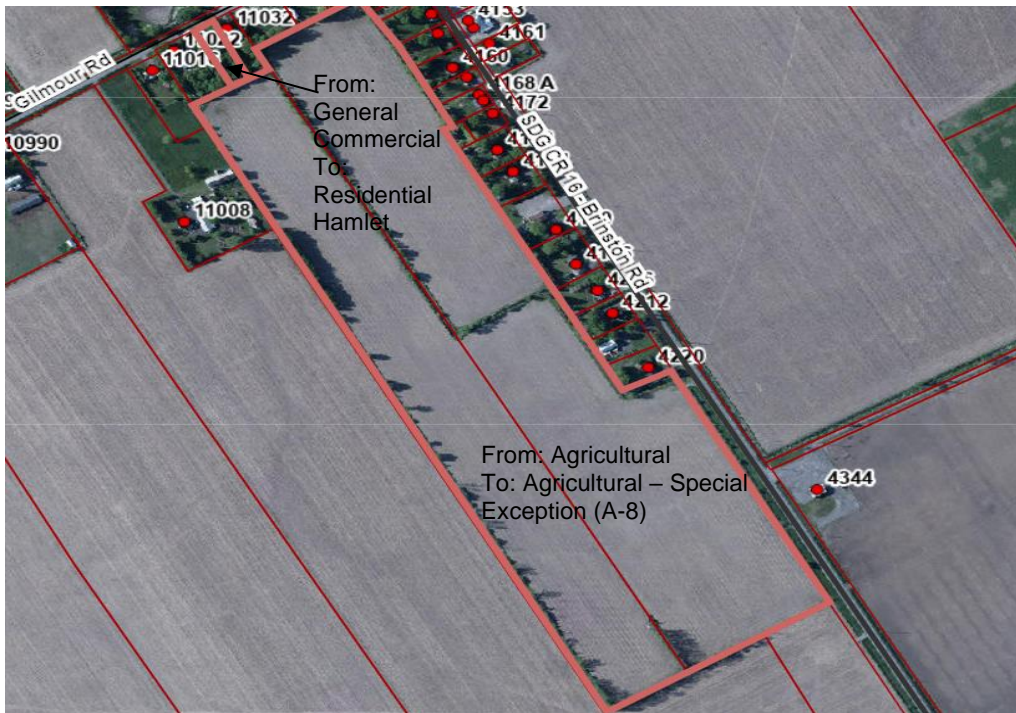

NOTICE OF PUBLIC MEETING CONCERNING  
A PROPOSED ZONING BY-LAW AMENDMENT  
PART OF LOT 19, CONCESSION 5  
11032 GILMOUR ROAD  
(FORMER TOWNSHIP OF MATILDA)  
BEING THE SEVERED & RETAINED LANDS OF CONSENT APP. B-73-22  
FILE NO. Z-2022-14 (LEWIS)**

TAKE NOTICE that the Council of the Corporation of the Municipality of South Dundas will hold a Public Meeting on the 12<sup>th</sup> day of December 2022, at 6:00 p.m. at the Municipal Office, to consider a proposed Zoning By-Law Amendment under Section 34 of the *Planning Act*.

This Public Meeting allows the public to comment on the zoning change request for the property noted above.

The purpose and effect of the Zoning By-law amendment is to rezone Part of Lot 19, Concession 5, being part of the severed portion of Consent Application No. B-73-22 from "General Commercial (CG)" to "Residential Hamlet (RH)" to address the existing residential use of the property. The amendment also rezones the retained portion of Consent Application No. B-73-22 less the severed portion of Consent No. B-74-22 from "Agricultural (A)" to "Agricultural – Special Exception 8 (A-8)" to prohibit future residential uses. The zoning amendment seeks to fulfill conditions of consent approval.

The Key Plan identifies the location of the property. This Zoning By-law Amendment is not related to any Minor Variance, Official Plan Amendment, or Plan of Subdivision.



ANY PERSON may attend the Public Meeting and/or make written or verbal representation either in support of or in opposition to the proposed Amendment.

If a person or public body does not make oral submissions at the Public Meeting or make written submissions to the Municipality of South Dundas before the By-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of South Dundas to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at the Public Meeting or make written submissions to the Municipality of South Dundas before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
