Rob Hunter informed that if new person interested in regular board regular position they should be confirmed at the next BIA regular meeting and that prior to the meeting David or Heidi should contact any current members that have been consistently absent to determine their status moving forward.

7. Overview of Municipal and Economic Development Projects

South Dundas Economic Development Officer, Rob Hunter

- Rob highlighted the recent street scape project that was not completed as originally intended due to budget constraints but that hopefully can be built upon in the future
- Victoria asked about plan to improve the accessibility between the walking path and the mall. Cole stated that he would look at the distance and discuss with council the possibility of creating a small path from the current path to the parking lot north of the mall near the Beer Store
- Rob also mentioned the closing of the land sale to the north of Highway 2 to Sofia which will hopefully have a plant up and running in 2 years and employ 150 people
- Tomlison recently purchased the old Port of Morrisburg to the east of the village and has been doing remediation
- Ross Video expansion in Iroquois almost ready for occupancy
- Municipality is participating in a Counties Growth Study to identify lands that could be used to expand business opportunities
- Victoria asked about support for current businesses and specifically parking lot improvements and Cole stated that that is a priority for council but he doesn't have any information that he can share currently. Kathy suggested that council coordinate with the owner of the plaza containing Cook's Corner and Cole confirmed that that will be considered.

8. 2023 Budget

Rob clarified that the -\$11,150 reserve funds was half of the current reserve funds and being used to offset an increase in levy for the 2023 tax year

operating costs (currently investigating sharing space with the SD Chamber of Commerce), last summer the board participated in a break out work shop to identify areas of importance to focus on in the near future, looking into median beautification project similar to Iroquois Plaza, Heidi has applied for 4 summer student positions and will know in early April if got funding)
