If a person or public body does not make oral submissions at the Public Meeting or make written submissions to the Municipality of South Dundas before the Bylaw is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of South Dundas to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at the Public Meeting or make written submissions to the Municipality of South Dundas before the Bylaw is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If applicable, a request is made that the notice be posted in a location that is visible to all residents by the owner of any land that contains seven or more residential units.
