6. GENERAL BUSINESS AND REPORTS

- a. Planning Goals/Ideas were reviewed and prioritized. Please refer to the Goal Setting Spreadsheet and the map of proposed infrastructure.
 - It was noted that Canadian Tire may provide money for park infrastructure.
 - Cole indicated he would bring the general concept to Council for approval before the committee moves ahead with infrastructure cost estimates.
- b. Movie Night is scheduled for Saturday July 22nd @5:30 pm. The movie will be shown in the park, will be free of charge and the Lion's Club will provide a canteen service beginning @5:00 pm with burgers, hotdogs, chips, popcorn etc. for a cost per item. Everyone is to bring a chair. South Dundas will do a poll to determine the level of interest in various movie titles. Once a movie is determined, David will order it and then bill the cost to the Lion's Club who will reimburse the Township. Once the licence is purchased, it is valid for one year. Nancy is to reach out to South Stormont to inquire about their movie nights and if they are doing it cheaper. In the event of bad weather, the movie location will be moved to the Morrisburg Arena. The lion's will advertise movie night at the canteen and at the sign board at 5th Street.

c. Project Updates

- a. David indicated that the new light bases have been backfilled, tree mulching and installation of beach sand is complete.
- b. The committee agreed to forward a motion to Council for shoreline plantings to continue to the finger docks. Chris is to inquire with Chloe Lajoie - the Natural Edge - to see if they may have any funding for the project. Costs and donations are outlined in the shoreline Planting Spreadsheet.
- C. The committee has decided that the lookout does not require lighting and recommends the posts extending above the rail be cut off just above rail height and capped.
